 - Marvella Starlin: Looking to replace ITSC 1301 with BCIS 1305 as it provides more useful information for the students to utilize in the field. It will not change hours. Three hours remain.
 - Kam Zinsser: BCIS 1305 includes word and excel. Do they need that in the field?
 - Marvella Starlin: Yes.
 - Rick: ITSC 1301 has it too.
 - Kam Zinsser: What are the differences?
 - Marvella Starlin: BCIS 1305 focuses on a business atmosphere which ultimately benefits the students by learning productivity, spreadsheets, and data bases. All that will be utilized in a doctor's office. ITSC 1301 does not cover the same aspects.
 - Members: They are very similar courses. ITSC 1301 is not offered as frequently which has been one of the problems. BCIS 1305 is offered more consistently.

- Jim Berry: The ACGM previously indicated only five criminal justice courses listed in the transferability list. This year, while redoing the syllabi, four additional courses were added to the ACGM. CRIJ 2301 needs resources and corrections. In the past, CRIJ 2301 has been listed as an approved elective and now it is placed as a transferable course. Request includes the removal of CJSA 1325 which is not in the ACGM list and make it the approved elective. CRIJ 2301 is a combination of a technical and academic course, and should be moved to the degree plan. No loss of course content since CJSA 1325 is the same course as Crime in America. Same textbooks can also be used.
